

Bicycle Use Terms & Conditions

The Owner supplies bicycles to its guests on the following terms:

Travel Insurance: It is the responsibility of Guests to hold their own travel insurance policy to cover personnel medical care in case of accident, and any third party liability that may arise from the use of the Bikes by Guests.

Obligations of Guests:

It is the Guests responsibility to:

- operate the Bike in a manner appropriate to prevailing road and weather conditions
- wear a helmet and other protective clothing. We have helmets on site but it is recommended you bring your own.
- know the relevant rules of the road and practice safe cycling
- know how to operate a multi speed bike.

Theft of and Damage to Bikes:

Subject to this clause the Guest is responsible for any and all damage once Bikes are received by Guests. This includes but is not limited to any form of theft and damage to the Bike. Guest will not be responsible for loss occasioned by the theft or damage of the Bicycle during the period when the Bikes have been stored in accordance with instructions provided to Guests i.e. in the locked garage.

Any damage will be quoted on for repair/replacement by an experienced Bicycle Retail Outlet and this amount charged to the Guest Bond.

Waiver: Guests acknowledge and agree that Rejuvenate Stays maintains no control over the operation of the Bikes by Guests. Rejuvenate Stays assumes no responsibility for and cannot be held liable for any personal injury, property damage, third party liability or other loss, accident, delay, inconvenience, or irregularity which may be occasioned either by reason of • any wrongful, negligent or accidental acts or omissions on the part of the Guest or the accompanying tenants • any defect in or failure of any vehicle, equipment or instrumentality owned, operated or otherwise used by the Guest • any wrongful or negligent acts or omissions on the part of any other party not under the control, direct or otherwise, of Rejuvenate Stays. Guests hereby release Rejuvenate Stays and its agents and employees from and against any and all liability arising during the period. Guests acknowledges that they are aware of the risks involved with cycling including but not limited to physical exertion, forces of nature, accidents, travel via any mode of transport, adequacy of medical facilities, or negligence (other than wilful or fraudulent) on the part of employees, agents or others of Rejuvenate Stays. Guests agree to be responsible for their own welfare, and accept any and all risk associated with the activities they undertake. Guests agree that the terms herein are binding on them, their family members, heirs, successors, assigns, dependents and/or minors accompanying them, and their legal representatives. Guests acknowledge and agree that Rejuvenate Stays and its agents have the right to refuse participation by any person judged incapable of activities, and for not executing this document or other required documentation. Any dispute arising out of these matters whatsoever, shall be resolved in binding arbitration/adjudication under the laws of the country of Australia. Any part of this document found to be void or unenforceable shall not negate the enforcement of the remainder.
